**REQUIREMENTS TO PARTICIPATE IN THE 2018 LOGAN COUNTY JR. FAIR:**

- I. Registration will begin 25-35 minutes before the start of the day's program and end 10 minutes before the program begins.
2. Full time attendance is required. The doors will be shut promptly at the start of the program. Students are required to be on time and stay for the full program. Participants who arrive late or leave early will be required to attend a different session.
- 3. Parent or guardian is required to attend, regardless of age with their child if they are a FIRST year livestock exhibitor.**
4. Livestock exhibitors whose projects include: Market Steers (T-Bone and Dairy Steer), Beef Breeding projects, Beef Feeder Calves, Market Hogs (Barrow and Gilt), Sheep (Market and Breeding), All Poultry Projects (market, pullet, fancy, production, bantams, breeding, including ducks, geese, and turkeys), Rabbit (Market, Breeding and Pet), Dairy Beef Feeder Calves, All Dairy Cattle projects (including all heifers, cows in production and dry), and all Goat Projects (including does in production and dry, market, angora and pygmy) must attend one of the QA programs listed above or any QA program offered out of county **(IF YOU ATTEND A QA OUT OF COUNTY IT IS THE EXHIBITOR'S RESPONSIBILITY TO HAVE THEIR CERTIFICATE TURNED IN NO LATER THAN 4:30PM ON May 1, 2018 TO THE LOGAN COUNTY EXTENSION OFFICE),**
5. There will be a \$2.00 fee per exhibitor to cover the cost of supplies.
6. Exhibitors of the above mentioned livestock projects will be required to have a completed DUNF (Drug Use Notification Form) on file for each animal with the Sr. Fair board to be eligible for participation in the 2018 Logan County Fair. (Due at Fair time during weigh-in.) (A reminder you must use the proper form, or will be asked to fill out a new one)
7. A Logan County Fair Pass (\$5.00) will be used this year. You will be required to have the pass punched upon entering the fairgrounds and you must get a wrist band upon leaving to reenter. An advisor will supply a list of exhibitors and advisors by June 1 to the Logan County Fair Grounds. A payment will need to be included with the list. A club will need to purchase season passes, if not received by June 1. All advisors and committee members will receive the Logan County Fair pass each year.
8. To be eligible for test out, you must be 12 yrs of age by January 1 of current year and not a first time livestock exhibitor.
- 9. PLEASE DRESS ACCORDING TO THE WEATHER THE PROGRAM WILL BE INSIDE AND OUTSIDE.**
- 10. A FEE OF \$200.00 WILL BE CHARGED FOR ANY LATE CERTIFICATES.**
